### INTRODUCTION

The concept of the Quarantine City must start with the realization that Covid 19 is World War 3. Most of humanity does not realize we are in a World War that began in 2019. This virus, with its enhanced functions, is not natural but a military weapon. The emerging evidence points to the virus being created in a laboratory and strategically released.

This war has shown us is that the enemy of mankind is no longer a country, an ideology, an organization, or a military power; that way of thinking is long gone. Instead, the greatest enemy of mankind in the 21<sup>st</sup> Century are super viruses and germs; the second is Cyber terrorism. But I will leave the second for another time.

This war will last for at least a decade. The only countries that will come through this war relatively unscathed in their economy and escape further viral mutations will be those nations that implement this concept - the more countries that participate in the program, the greater chances of a victory for mankind. The alternative of doing nothing is just madness.

The first step is for our politicians to understand that lockdowns are counterproductive in every way we look at them. The condition of national lockdowns is a setback of at least 100 years in our global economic progress. The good news is, this concept, once implemented, allows us to reactivate the engines of the airline and travel industry in which all countries are heavily dependent.

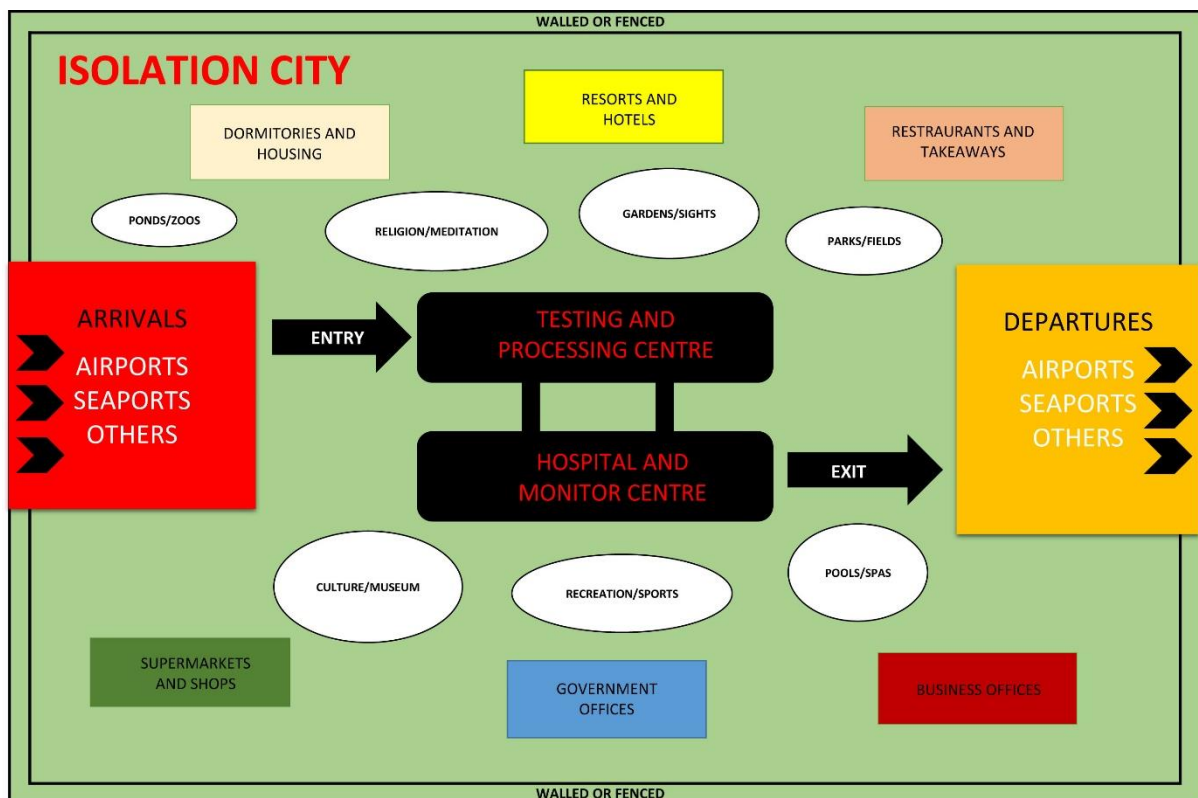
The significant advantage of the project is to eliminate the lockdown situations that affect the commerce and the livelihood of countries. The Quarantine City concept is a City with

everything in it, fenced/walled, secured, and isolated from the general population. Its sole purpose is to quarantine people and treat Covid 19 cases and other infectious diseases.

It is a standard today that a City is designed with a single purpose in mind, for example, Las Vegas – a gambler's paradise. Dubai – a mega tourist and retirement haven. New York City – a traders and bankers paradise, etc. How much more a City that is specifically designed to save lives and protect lives. It makes complete sense!

A word of clarification. This Quarantine City concept is not a City in a bubble that first sparked the world's imagination when His Highness Sheikh Mohammed bin Rashid Al Maktoum in 2019 thought it a good idea to encase a City inside a glass dome. It is an ingenious idea for a City and could well be the future model, but it is not the model for this City.

## THE GLOBAL SITUATION

It is now one year after World War 3 began, and the following universal facts have emerged;

1. Covid 19 is here to stay. The virus has mutated as the experts predicted, and they are warning more deadly strains will appear in the future.
2. Covid 19 vaccines partly work. The vaccines are only effective against the strain for which it was created but do not provide continuous immunity against new strains.
3. Covid 19 is not a typical viral disease you catch once. The news has reported many cases of people who have been vaccinated and re-infected.
4. Covid 19 Quarantine facilities are not working. The virus is still getting through the net of hotels/accommodations used to isolate travelers.

5. Covid 19 is naturally curable. As studies have shown, the virus must be allowed to take its course, and herd immunity is achievable, but the risk is not minimized.
6. Covid 19 is overwhelming our health system. Hospitals everywhere are not coping with the outbreaks, and the fatalities continue to climb.
7. Covid 19 particles penetrate masks. Cotton masks, surgical masks, and N95 masks reduced the transmission of coronavirus droplets but didn't completely block all particles, the University of Tokyo research team found.
8. Covid 19 will bankrupt countries if their borders remain shut. The economic cost of not having tourism will result in the permanent destruction of many local businesses.

A UK Government report warns COVID could become 30 times more deadly!

“UK's Scientific Advisory Group for Emergencies (SAGE) says multiple variants of coronavirus such as Alpha, Beta or Delta could merge into a deadlier variant over time. This is called a 'recombination event' and is well documented with Flu. If this occurs, COVID-19 could turn into something similar to Middle East Respiratory Syndrome (MERS), which had a 35 percent fatality rate. If COVID-19 was to become as deadly as MERS, the mortality rate would be 10 to 30 times more deadly; COVID-19's current mortality rate in Australia is believed to be about two percent and could increase to twenty to sixty percent. SAGE made a number of suggestions on how to mitigate risk with a possible variant mutation, including vaccine booster shots and strategies to reduce transmission. The panel advised there is a chance the SARS-Cov-2 virus could become less deadly, but this expectation is unrealistic in the short-term.”

A Covid-19 C.1.2 new variant of interest has been discovered!

“While Australia is making great strides in vaccination, hold-on for another potential game-changer. And get vaccinated, not with panic, but determination. The C.1.2 variant originated in South Africa. It is reported to have a mutation rate of 41.8 mutations per year (about 2x faster than other variants) and maybe more infectious and vaccine-resistant than Delta. And it's spreading. Since detection in May 2021, when it accounted for 0.2% of genomes sequenced in South Africa, it's grown to 2% (10 fold) in July 2021. A similar rate of spread to Delta. C.1.2 has been detected in England, China, Portugal ... and New Zealand. At this time, C.1.2 is classified by WHO as a Variant of Interest. It has not reached the level of Variant of Concern. But it contains mutations found in other Variants of Concern, such as Delta. The COVID-19 story is not over ... by a long way.”

In summary, the global situation is terrible, and the future looks bleak, but there is a solution if a Government will prioritize this concept.

It is possible to contain and manage the disease and effectively stop its spread, allowing countries to reopen their borders and resume international travel. This is what this proposal offers your esteemed country.

## **THE DEFENCE STRATEGY**

We need a long-term defense strategy that works and will allow countries to open their international borders no matter the health crisis in other countries. The fact is no country at present has the facilities to handle a pandemic. Understandably no one prepared for this war, but instead, governments poured billions into arming themselves for a nuclear war they can never fight.

Medical experts tell us Covid 19 is a different kettle of a virus – it has the gain of function features. But, they warn us, more deadly strains of the virus are coming, and our vaccination

program is inadequate to stop the new strains. Moreover, experience in other nations like Israel shows that people vaccinated are still getting the virus. In countries like the USA and Germany, younger people are getting infected. The mandatory wearing of masks is not working.

The frontline protection for all countries has been a quarantine strategy, where the entire country goes into lockdown, with an enormous cost to the country. How long do you think we can permit this situation to continue without bankrupting the country? Everywhere the hotel and resort industry is decimated and will remain dormant as long as countries close their borders.

Further, the idea of a travel bubble between countries is not working because the virus will inevitably get through, and the lockdowns will resume, as seen between countries that have tried this solution. Travel bubbles are a risk not worth assuming because it does not provide a full-proof barrier against the disease. Lockdowns will always occur.

We need a defense strategy that will provide a permanent long-term full-proof solution and offer people the option of not being vaccinated. Why force people to be vaccinated when much of a country's population will never travel abroad. The unfortunate result of forced vaccinations has been many people have died from the vaccine and will continue to do so.

The proposed strategy is to create a Quarantine City with a Covid 19 hospital - a "bubble" within every country. The idea already works on a country scale, as proven by the many countries that have instituted quarantine measures for travelers. This solution is not a new invention but an upscale of what already works.

## THE QUARANTINE CITY

The idea of a Quarantine City is over 5,000 years old. It first appeared in the Law of Moses, where a City of Refuge was purposely created or designated to harbor people who had accidentally killed another person. Under the same law in the Torah, isolated colonies for lepers and other contagious diseases the Priests deemed incurable are mandated. Throughout antiquity, the idea was implemented with great success and was a standard in the Muslim world with the great physician Avicenna.

Quarantine Cities worked then, and it will work now for our generation. The isolation of contagious diseases is a medical no-brainer in this generation of advanced science. By law, non-infected citizens must be protected at all costs from the carriers of the viruses. Medical research shows that all viruses have an incubation stage where we can know if a person has been infected or not. Only after that period is people cleared to return to public life. This is the general idea behind quarantine facilities.

The concept of a Quarantine City is one massive quarantine center. It is designed to have everything in it that an ordinary City would have, but its units and components are highly protected so that the people who work there are not adversely exposed. The highest level of quarantine technology is concentrated in the City. The hygiene level of the City is acute with continuous disinfection of all public areas. Everyone who works in this city is under Quarantine and cannot leave the City unless they pass quarantine measures.

The ideal location for such a development is where there is already an international airport and seaport. Thus, all travelers' local and international borders are immediately sent to the City to undertake a two-week isolation time. They are not treated as hostiles but as holidaymakers. The major difference from the Quarantine facilities we currently use, like hotel establishments, is that the City is designed for this purpose alone.

The benefits are such an arrangement is enormous:

### **1. The immediate containment of viruses**

This solution eliminates 100 percent the risk of infecting citizens in a country from external travelers. Travelers and local people who are infected are isolated from the general population. The spread of the virus is immediately contained and treated. The City will have all the latest medical equipment and the most advanced testing facility to ensure nothing gets through the net. People who have the disease can be quickly isolated and treated, and returned to their country free of the virus. This area will have a specialized Covid hospital that is designed to treat virus infections. Also, people who want can be vaccinated here.

### **2. The monitoring and control of virus**

This solution is the most cost-effective way to monitor and control viruses. Infectious diseases can be tested and monitored away from the general population. Cases treated and released can be monitored from the center with tracking technology for several months if required. At present, the local Hospital in a country is tasked with monitoring and controlling diseases and has become stretched to the limit of what they can do. Our hospitals are not designed to handle pandemics. A National Hospital's only commitment is to vaccinate our general population, which must be done outside this area.

### **3. The containment of new viruses and diseases**

This solution will contain the spread of the new virus and new diseases. In these cities, new strains can be discovered, and international alerts made. Once a virus is released into the general population, it is difficult and costly to reverse the damage. Local hospitals are not equipped to handle these situations. The Quarantine City will have laboratories to test for new virus strains and catch new diseases coming into a country. At the moment, no such specialized facilities exist in most countries. At present, the containment of the spread of the virus is done by locking down the country.

### **4. Productivity is restored to travelers**

This solution solves the inconvenience and complaints of travelers where they cannot enjoy or do business in the country while in Quarantine - a non-productive time for everyone. Every tourist can start the first 14 days of their holiday being introduced to people of that nation, enjoy the beach, see a few sights, do shopping, do business, set up a company, see lawyers/consultants while waiting in Quarantine, etc. People here can also play a sport, attend fitness facilities, and meditate, etc., while quarantined. Life can go on as usual. When they are released, the rest of the country is a bonus, and further business or pleasure can resume.

### **5. Productivity is restored to the nation**

This solution solves the situation of national lockdowns that are destructive to a country's commerce and economy. The sources of infections are eliminated, and diseases do not enter the country. Business everywhere in the country can resume as normal. Merchants and Retailers do not need to observe quarantine regulations that put a burden on their business. For example, having to construct special barriers, Implement social distancing signs and rules and limit traffic, require people to wash their hands with expensive solvents, and disinfect the place after a customer leaves.

### **6. The freedom of choice is restored to travelers**

This solution solves the situation where all travelers are herded together into one place where

their socioeconomic status is of no relevance. This is not the way a country should be treating its guests. All travelers will have accommodation options, restaurants, and entertainment they can afford in their budget because the local Government should not be footing the bill for travelers. The beauty of this solution is that it earns money for the country, and all travelers can enjoy the selection of the options available to them. Tourism can resume as normal.

### **7. A source of revenue**

This solution brings revenue for the country and allows tourism to resume as normal. At the moment, lockdowns earn the country nothing and are destroying local hotels and resorts. Tourism packages can be structured to include a connection holiday outside the quarantined city where all local establishments open as usual. For example, a person that spent two weeks in the Quarantine City once certified virus-free can spend the next 7-14 days enjoying the rest of the country they did not see. Thus, travelers will spend more money.

### **8. The elimination of double quarantine**

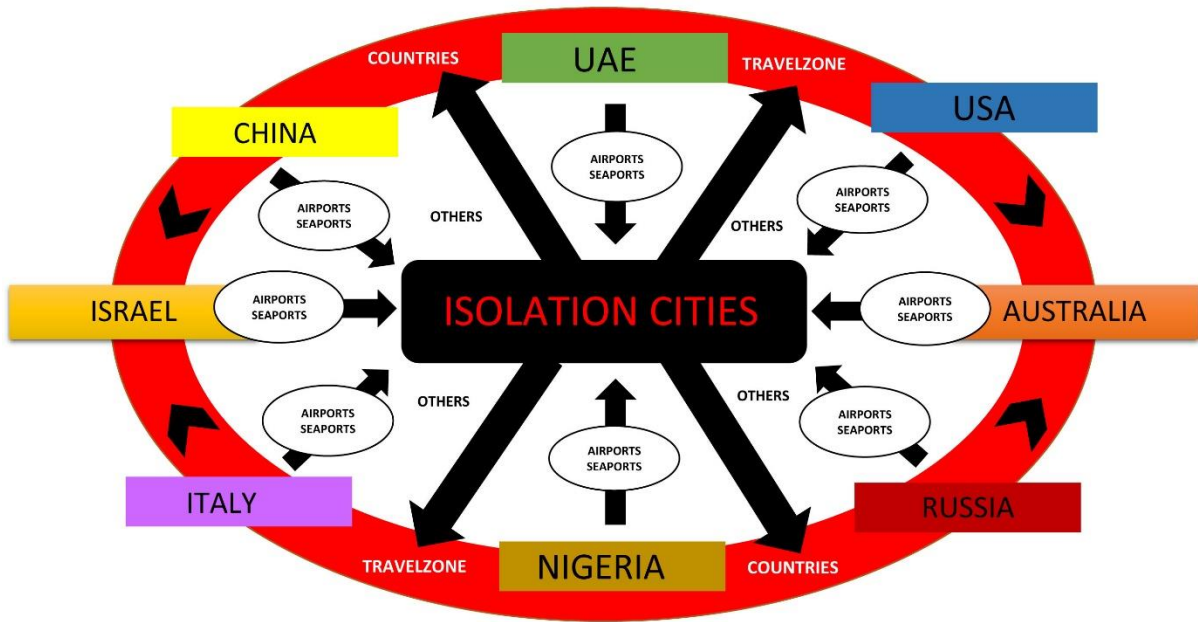
This solution eliminates the need for double quarantine. The major complaint from international travelers is that they must quarantine twice, once in the destination country and again when they return to their home destination. Under this system, countries that have a Quarantine City need only quarantine their travelers once. Once a visitor is certified as virus-free and vaccinated, they can return home without going through quarantine again in their country. This saves the country much expense in quarantine of their citizens. This solution will only work between countries that are certified as having Quarantine Cities.

### **9. The most cost-effective solution**

This solution will not bankrupt a country because it is designed to earn the country money. However, vaccination programs are an ongoing cost to a country because new strains develop, requiring an ongoing vaccination program. Implementing this one-time solution will save the country millions in vaccination costs. Over five years, the cost of revaccinating people will be much more than building a one-time Quarantine City. Most countries already have a city, town, or area to allocate with minimal development money.

### **10. The prevention of international crime**

This solution has an added benefit for a country. In a free travel situation with no quarantine of luggage, criminals entering a country can easily slip through the security net. Drugs, drug money, and other illegal substances are brought readily into a country through international borders. The screening of passengers and luggage at our international airports does not deter criminals. In this solution, criminal activity can be discovered because there is time to sort out the criminals from law-abiding citizens. All luggage must go through the same quarantine procedure as the person.



## THE HOSPITAL CENTRE

The heart of Quarantine City is the Covid 19 Hospital and Testing and Monitoring Centre. All activities and services in the City are connected to the Hospital Centre. This Hospital is not your ordinary local Hospital but an extraordinary place designed for the testing, treatment, containment, and monitoring of infectious diseases. A state-of-the-art hospital designed and built by Mr. Ben Notley from Australia. It is called the Notley Hospital. All Quarantines Cities must have this Hospital for it to work.

Mr. Notley has built hospitals for over 20 years, and he invented the Ripod, a pod designed to isolate and ventilate people who have collapsed lungs or breathing problems. It is a negative pressure room designed for Covid 19 victims. His Company holds a patent to the technology, which is incorporated into the design of the Notley Hospital, the first of its type in the world. The Hospital is built around this proven technology that destroys the virus.

## The Ripod

Medical research shows that the Covid 19 virus attacks the victim's lungs, causing the lungs to collapse, requiring a ventilator machine to breathe. Sadly even with the ventilators, many still die because oxygen does not get into the victim's bloodstream. My pod is designed to put oxygen directly into the patients' bloodstream through negative pressure. The technology is proven worldwide, and it works. It is not a cure, but it will keep patients alive in their critical stage to aid in their rapid recovery. The hospitals that use this technology have not had the fatalities numbers.

On the Company website [rescuepod.co](http://rescuepod.co), they show you how this technology works and how it is organized. As a point of fact, the pods are not exclusive to infectious diseases; they can be used to treat many other medical conditions. For example, strokes, heart failure, high blood pressure, asthma, accident victims. Inside the pods and Hospital is equipment that completely kills the airborne virus and stops the spread of the disease.





The Covid 19 pandemic is global, and in the cities where the disease has broken out, the medical facilities have been completely overwhelmed. Standard hospitals have not been able to cope with the outbreaks because they are not designed for infectious diseases. In some countries, local oxygen systems have been overrun, and people are left to die. The reports from the news of uncontrolled outbreaks show a horrific situation, with doctors and nurses having to decide who lives and who does not.

### **The Notley Hospital**

The Notley Hospital is a Modular Hospital that uses isolation pod technology to test, treat and control contagious illnesses and epidemics and eventually eradicate them. It is the only Hospital of its type in the world specifically designed to treat and stop Covid 19 and is amazingly expandable, movable, and updatable. It is created to preserve and save lives in an emergency anywhere in the world and whatever climate.

The good news is that the Hospital is available now and can be set up in any environment in 3-4 weeks after arriving in the country, unlike the old way, which takes 2-3 years to build a Hospital on site. Furthermore, the entire project can be completed within 4-5 months from the construction to shipping to the installation. This is unheard of in this industry.

The Hospital will come complete with the latest equipment and technology. Equipment that is of military-grade the best in the world through the companies we have partnered with. In addition, the Hospital has a chemist, laboratory, X-Ray machine, and emergency surgery room.

In addition, the Company can also supply Quarantine Mobile Units complete with living quarters to accommodate families and individuals specially designed to kill and remove the airborne disease with a testing and discharge facility. Most countries use hotels and private accommodation to isolate travelers that are not equipped to handle the virus. They have been proven to spread the disease. This project is separate from the Hospital and is available on request.



## THE COST TIME FRAME

Typically a 200 patient, conventional Hospital will cost anywhere from 50 to 100 Million USD, but we have reduced it to a fraction of the cost making it affordable for every country. The prices quoted are unheard of in this industry. The funding needed for a 200 patient capacity hospital is 24 million Australian, including installation. It does not include the local costs of the project, the site preparation work that is part of the City planning. What follows are the Hospital specifications.

In addition, the Quarantine City will require specialized accommodation, housing, government, commercial establishments, recreation facilities, and security modules that are all Covid safe. The price and size of these facilities will depend on the country's projected arrival and departure statistics. The topography and geography of the area will also determine the cost. The price to build a Quarantine City from scratch can be anywhere from 100 million to 10 billion USD. The overall cost boils down to the capacity a country requires.

More than a hundred years ago, it would take 10 to 50 years to build a City. With modern technology, we can construct a City in 1-2 years. China has shown that it has the technology and skilled labor force to build a modular City in 12 months. They have demonstrated that a sky scrapper can be installed in a matter of week's built-in mega factory. The Company factory in Australia also can manufacture a modular city, and many other countries have this ability. We have the technology and ability to do it in many advanced nations. The global employment possibilities are staggering.

## THE WAY FORWARD

The cost should not deter us because there is a way to raise the money and fund the project without putting countries into poverty. Every year the combined world spending on armaments is 2-3 trillion dollars. Suppose our world leaders declare a one-year moratorium on arms spending and commit this money to this solution. In that case, we could solve the Covid pandemic with the Quarantine City solution in 12 months. This is more than enough money to build 1,000 Quarantine cities and save billions of lives from infection and death.

Albeit the way forward for this solution to be accepted globally, the United Nations and the World Bank must agree to a mandate to make the Quarantine City compulsory for all countries. Unfortunately, many countries are not in the position to build a Quarantine City because they do not have the funding or the capability; therefore, this program must be funded by the World Bank or the International Monetary Fund on a soft loan basis of 1% over 30 years with a margin to expand the City's capacity.

In addition, many countries will require multiple Quarantine Cities due to their size and geography. However, the design should be standardized according to the World Health

Organization (WHO) guidelines. A new rule book for a Quarantine City needs to be written, and its laws and regulations mandated globally.

Every Quarantine City must pass the WHO guidelines and examination criteria before being admitted into the World Travel Zone. Countries that do not have a Quarantine City or comply with the requirements must be banned from international travel. In addition, a country compliance timeline must be set and a world date for completion determined. This solution applies only to international travelers; it does not apply to Shipping and Air Freight services on which countries are dependant.

## SUMMARY

The Quarantine City is an ancient yet proven solution. The viral attacks and outbreaks will not stop; more pandemics and other crises will come. The Quarantine City concept is the only real cost-effective solution we have, and it works. A solution in which will allow us to reopen our international borders and not shut them again. International flights and resorts and hotels can reopen permanently, and local industries resume normally because people, for the first time we will have 100 percent protection. The global vaccination program and mandatory wearing of masks cannot achieve what is proposed in this solution.
