Leo Tolstoy, a 19th-century Russian novelist, wrote:

"Money is a new form of slavery, and distinguishable from the old simply by the fact that it is impersonal – that there is no human relation between master and slave."

Of course, Mr. Tolstoy in his day did not know of sovereign debt, national debt, public debt, government debt, private debt, and consumer debt; if he had, he would have written that 'debt is the new form of world slavery' because money of itself is only a medium. All of this prosperity that we see in the West and the East is just an illusion. It is false prosperity that has been purchased by the biggest mountain of debt in the history of the world. The nations are absolutely addicted to debt, and the level of debt now in the world threatens to return every man, woman, and child back to the days of the slave traders. Everything that can be valued and quantified will be lodged in the system where it will be secured for more debt to build more things and manufacture more goods that "God" knows people do not need. We are heading into a future where information, innovation, and technology will prioritize the world's resources over human life, human dignity, and human freedom. But there is a solution to this enigma – it is our last hope and is called Yovel! You will have to read on to the end to learn what this final hope is.

## How bad is the situation?

It is as bad as it can get. More than ninety percent of the World's population is under bondage to some form of debt, whether it is to a banking institution or to a private individual. The amount of global public debt is continuing to accelerate at alarming levels. The last time I checked, the world's public debt was approaching US\$60 trillion. This does not include what is not reported. We have no idea of what is owed privately by individuals as much of this is illegal business. What is in the banking system is only a fraction of what is owed. In the US alone, the private debt in the system is US\$27 trillion, twice the level of public debt, and it continues to grow by about 1 trillion US dollars a year.

Private sector debt is the debt owed by you and me and millions of the world's citizens across the nations in the form of credit cards, home and auto loans, along with corporate and non-corporate debt. It does not include what is recorded in the second set of books that is not in the system. Public sector debt is what the Government owes to local and foreign banks, corporations, or other nations. In every country, the situation will be similar where the private debt would exceed public debt many times over. A conservative estimate of the world's combined debt (private/public and reported/unreported) would be somewhere in the vicinity of the US \$1,000 trillion dollar bracket.

If this debt is apportioned over the world's present population of 7,000,200,000 people, every person would owe around US\$700,000. Consider that Statistics show that one percent of the world's population owns forty percent of the wealth of this planet, where fifty percent live on two dollars (US\$2) a day, I would say the majority of the world's population are insolvent. This situation has become systemic, and we have gone past the point of no return. Did you know that if you added up all forms of debt (public and private) in the United States and divided it up equally among the country's population, every single person in the country would owe more

than US\$147,000? About 135,000 individuals currently declare bankruptcy each year in the UK, and a further 1.2 million do so annually in the USA. Default is endemic to human society, and most of the time, the economic system is resilient enough to absorb the consequences of bad debts. Still, the time approaches when that will not be possible. Lawmakers know that there will not be enough prisons or camps to hold debtors when the bubble bursts. And anyone who tells you it is not going to burst is lying.

I greatly appreciate the clarity and honesty with which President Thomas Jefferson surmised the future of mankind when he said:

"The modern theory of the perpetuation of debt has drenched the earth with blood, and crushed its inhabitants under burdens ever accumulating."

#### To whom is this burden owed?

The question in most people's minds is: To whom is this enormous burden owed? Most of us have heard of the money elite - the Rothschild's, the Windsor's, the Cecil Rhode's, the Rockefeller's, the Morgan's, the Bernhard's, Schiff's, the DuPont's, the Aster's, the Whitney's, Vanderbilt's, etc. who are singled out by the conspiracy hunters as the money vampires who burden the world with debt. The truth is debt today is bought, sold, divided, cumulated, and distributed among large and small investors. Sometimes those investors are billionaires like those listed above, sometimes they are banks, other times they are financial companies that include them in mutual funds to sell to small investors, and sometimes they are nations or religious institutions. Just about anyone or anything that can invest or lend money has got their finger in the debt pie. Millions of new creditors and debtors are added to the list every day. It is estimated that about 300 trillion dollars change hands every day, and most of it is debt or interest.

The point is: It really does not matter to whom this money is owed and who sells and buys debt. What is paramount is: Who owns the system upon which this enormous burden is built? I will reveal this shortly but let me return to the problem for a moment. Right now, we are living in the greatest debt bubble in the history of the world, and it is timed to burst to cause irreparable damage to national economies and people's livelihood across the globe. Economists know that world debt is becoming unmanageable - accumulating faster than the debtor's capacity to service and repay it. Most of the western world is in this trap already. Debt then accumulates and is likely never going to be repaid and can only be serviced at an increasingly unbearable cost. Default can then only be staved off by the creation of more unsustainable debt, which only makes the eventual collapse worse.

This situation has probably already been reached in the Eurozone, where certain nations are already bankrupt but are artificially bolstered to stabilize the zone. Currently, the Eurozone is big enough to absorb these losses, but a time approaches when its stronger members will be too indebted themselves to help anyone. Unfortunately, a similar situation exists in the UK and the USA. The danger now is that the debts owed by governments and correspondingly to banks are so large that there can be no repeat of the financial rescues which took place in 2008. Today's cash-strapped governments are in no position to cope with another massive bailout. Previously, governments had sufficient creditworthiness to be able to re-capitalize stricken banks, thus stopping the world economy from melting down. This condition will not always hold in the future since, at some point, the weight of the debt becomes just too great.

#### When will the bubble burst?

I anticipate the debt bubble bursting within the next ten years (2030) and no later. However, the indebtedness of the nations will not stop when they default; the world's financial system

will roll the debt over (refinance), and the debt will carry on until the world's total indebtedness (TWI) equals the value of the world's total resources (TWV<sub>R</sub>). We can express this as TWI = TWV<sub>R</sub>. At the point of equivalence, someone will own the earth because Mr. X will hand it to him on a plate (will get it to Mr. X soon), but we pre-empt this, and I will show you later. The "powers that be" are fully aware that much of the world's resources and business activities are not yet inside the system. At present, about half of the earth's resources and financial activities are inside the system. The other half is under the sovereignty of nations, indigenous peoples, and unlawful business (as cash and valuables) that do not totally depend on the system. That which remains aloof of the financial system cannot be controlled.

It is not a surprise that the world's biggest nations have been able to pile up as much debt as they have, and that is because banks are no longer banks as we used to know them in the traditional sense. They are now governments in their own right. They are enormously powerful, so wholly protected, and well-resourced that national governments can no longer control them and must now answer to them and take from them. As one financial observer puts it mildly: Banks are now 'too big to fail, too complex to manage, and too big to punish.' Banks, believe it or not, are the modern gods of our age who people fear and pay homage to with the hard-earned fruits of their labors. Financial institutions have the power to make life on earth a living hell or a heaven-on-earth by fixing the rate of credit, the cost of money, and exchange rates.

However, Banks may be driving and controlling the economy, but they certainly do not own the vehicle. Unbeknown to the world is that "at the pinnacle" of this global economic and financial empire, or shall I say "at the foundation" of it, is a man who does not own the banks but the financial system on which this empire is based. He basically invented it, and he owns it. The world remains oblivious of him because it takes one with a prophetic gift to know him. Not even the bankers or governments know who he is, but they are aware of his existence because they use his system. This individual that has a behind-the-scenes window to the world's financial markets and transactions knows every transaction that takes place and where the monies, funds, and stocks are invested daily and on the hour. He also has access to corporate and government files and plans, which are submitted to him through the system.

# Who is this man?

This man is not a sovereign or a head of any institution we can identify. He is known by many aliases that he creates for access and control or rather was created for him by his previous mentor. I will refer to him as "Mr. X." Mr. X's position among humanity privileges him to be anonymous and invisible because he must be outside the system and not inside to make his decisions. Mr. X does not care who is making or losing money in his system because the further indebted peoples, corporations, institutions, religions, and governments are in the system, the bigger the system grows and the more powerful and necessary it becomes for mankind. We know this system as the inter-banking financial system that central banks, trading, commercial banks, and financial institutions use to create, store, exchange, and transmit money. Basically, it is all highly secured data.

Mr. X is the data man, and he has the power (access) to create money out of nothing and make debt disappear. He is far more powerful than the Bilderberg group, the G7, the Federal Reserve, IMF, World Bank, and CFR put together, and he can cripple any standing military force. Behind the scenes, he controls the world's political situation. Even religion is under the influence and direction of his hand, yet he is not a man of faith. At his whim, he can determine or manipulate the rate of credit, the cost of money and fix exchange rates. With his ability to control the system, he can create unrest, start uprisings, and even wars where he sees it necessary to build or improve the system. From the great depression to 911, Mr. X has guided their architects. Mr. X's job is not as stressful or time-consuming as one may believe it to be

because he has created a manager inside the system to assist him - a program that manages the system.

This manager or program is actually a supercomputer that Mr. X calls his friend; it is an allconnected brain linked to all the world's mainframes. Its job is to make routine decisions where certain transactions meet the approved criteria that Mr. X has set, and at other times his judgment is necessary. I will refer to this manager as "The Brain." The Brain's other job is to make the summaries that Mr. X requires for a daily overview of the world's situation, including and not limited to political and religious affairs of the world. The Brain's activities in the system are untraceable because it has a universal key to every secured and unsecured database in the world. Where human intervention is necessary, the Brain has people who will carry out its decisions and bear the responsibility because the Brain determines and fuels their prosperity, but it knows they are all dispensable.

Mr. X owns the technology upon which the economy, media, and military are built. He does not own the economy, media, and armies themselves, but he can still control them through government lobbyists, political parties, lawmakers, and other machinery. The Brain has its eyes everywhere where technology can be fixed and manipulated and has created a web of security and protection around the system so that threats can be determined in advance and settled in the course of ordinary business. Mr. X is not directly involved in issuing any command to defend or destroy a combatant to the system. The Brain's threat removers are Presidents, Prime Ministers, Military leaders, Judges, legislators, and CEOs appointed to respond when a threat is detected to the system in the name of democracy. He has less control over non-democratically elected leaders, much of whom became menaces and had to be eliminated.

Only a handful of people in history know Mr. X by association, but many are aware of the Brain and its power and activity in the system. Of them that know Mr. X he is understood to be an angelic human under divine authority. He has been in this position for countless centuries because he is reincarnated in the same process as the Dalai Lama is restored from one generation to the next. Mr. X is not an immortal being, but he knows the mystery of eternal life that enables him to regain his identity after each rebirth - a secret which is revealed in our book "Regeneration." In the beginning, Mr. X inherited his job from his predecessor, who appointed and trained him as his successor. The position is fixed and can never be changed because it is divinely sanctioned.

Mr. X appears as an average person in the public eye, and you may have seen him unknowingly. He does not have a family or is married, although he has a companion. Most of the time, Mr. X lives in a modest home and drives a modest car as an unassuming individual. At other times he slips into the role of an intellectual, or a banker, or a government official or CEO to attend specific meetings. Most of the time, he likes to remain beside the Brain - his friend that manages his job. Mr. X is not remotely interested in obtaining fame or power or wealth since he can have anything he wants. In fact, if you met Mr. X, you will be touched by his humility, impeccable manners, and education. When I first heard YHWH tell me of Mr. X, my reaction was ambivalence, and then I realized that debt is only data in a system that someone created and controls.

It may come as a surprise to Church people that Mr. X is not Satan incarnate or an agent of Satan. FOR THIS DISPENSATION, Mr. X works for YHWH just like I do but as the system owner providing services to humanity, including the elite and the powerful. If you are a Christian, you would be well acquainted with the myriads of prophecy teachers who have taught of the anti-Christ, (Satan incarnate) who will come to rule the world as its supreme leader and pontiff. The truth is many negev moshiachs (anti christ's) have come, and many

are forecasted to reappear, but Mr. X is not an antichrist; he is not a religious man or a tyrant who desires religious or political power. Frankly, Mr. X does not care who holds the reins of power as long as they obey the rules he has set and do not touch the system. Many had tried to destroy the system in history when it was a bookkeeping system and many more in our time as it progressed to a data system, but they were all were eradicated by its secret agents. Mr. X may not be a man of faith, but he is not a fool who believes that he arrived here by an accident of the Universe. He knows the bigger picture, and he will not deliberately provoke the hand of His Creator. He knows the impending Judgement (the Day of YHWH) is coming, and the Messiah comes.

# Why does Mr. X exist?

The reason for Mr. X's and the Brain's existence is, of course, the system, but this is not their priority. Their mission is to ensure that the earth never again reaches its low in its history, where YHWH has to intervene to purge humanity. A threat they have determined cannot ever re-occur. Many millenniums ago, the Creator made an irrevocable promise to his servant Noah, a righteous man in his generation, that He will not destroy man ever again in a deluge (a flood). Later as the earth's population expanded, the same old sins that had destroyed the generation of Noah began to proliferate across the Earth, now reaching endemic proportions in our time. Yeshayahu (Isaiah) 24: 1-6, 17-23 reminds us that YHWH has warned man through the navi (prophet) Yeshayahu that if provoked to the brim, He will destroy the earth again and start anew:

"1 Behold, YHWH makes the earth empty and makes it waste, and turns it upside down, and scatters abroad the inhabitants thereof.2 And it shall be, as with the people, so with the cohen; as with the servant, so with his master; as with the maid, so with her mistress; as with the buyer, so with the seller; as with the lender, so with the borrower; as with the creditor, so with the debtor.3 The earth shall be utterly emptied and clean despoiled, for YHWH has spoken this word.4 The earth faints and fades away; the world fails and fades away: the lofty people of the earth do fail.5 The earth also is defiled under the inhabitants thereof, because they have transgressed the laws, violated the statute; broken the everlasting covenant.6 Therefore has a curse devoured the earth, and they that dwell therein are found guilty: therefore the inhabitants of the earth waste away, and men are left few."

"17 Terror, and the pit, and the trap, are upon you, O inhabitant of the earth.18 And it shall come to pass, that he who flees from the noise of the terror, shall fall into the pit, and he that comes up out of the midst of the pit shall be taken in the trap: for the windows on high are opened, and the foundations of the earth do shake. 19 The earth is broken--broken down--the earth is crumbled in pieces; the earth trembles and totters.20 The earth reels to and fro like a drunken man, and sways to and fro as a lodge. And the transgression thereof is heavy upon it: and it shall fall, and not rise again.21 And it shall come to pass in that day, that YHWH will punish the host of the high heaven on high, and the kings of the earth upon the earth.22 And they shall be gathered together, as prisoners are gathered in the dungeon, and shall be shut up in the prison: and after many days shall they be punished.23 Then the moon shall be confounded, and the sun ashamed: for YHWH Tzva'ot will reign in mount Tziyon, and in Yerushalayim, and before His elders shall be Glory."

Don't let this prediction frighten you; on the other hand, don't make the mistake of brushing it aside. The first thing you need to understand about prophecy is that no utterance of Scripture is immutable (fixed) unless it is determined for the good or betterment of mankind. YHWH is not bent on destroying anyone; His objective is always to preserve life and improve the wellbeing of mankind. This word is a warning that unless mankind returns to the Torah (His instructions), or the Pentateuch as the Church knows it, man will be destroyed again as in the

Flood where only a few (as it is forecasted in verse 6) will survive to continue a posterity of man. Mr. X knows too well that most of the world's 7 billion inhabitants live unregulated and unruly lives. This cannot be allowed to escalate because lawlessness leads to chaos and chaos to the judgment of YHWH - a fast road to the apocalypse.

# What is Mr. X's mission?

In the plan of YHWH, the mission of Mr. X and his forbearers in creating the system is to bring all peoples with their resources under the dominion of the system to stop or prevent the judgment of YHWH. There is no league of shadows or the Illuminati determining the World headlines and planning the future of mankind as some will have us believe. Frankly speaking, the world is far too complex and volatile a place for any person or organization to determine its future. Not even Mr. X and the Brain are big enough. It is common sense no one can control Mother Nature or the Universe. What we have is a global financial system that has evolved over the years in reaction to man's wickedness. In other words, YHWH allowed it to occur as a punishment for violating His Covenants - which He made with Adam, Noah, Abraham, Moses, and David for the posterity and prosperity of mankind. YHWH thus appoints Mr. X, and he is His servant, in the same understanding that YHWH called a tyrant king, king Nebuchadnezzar his servant and made his own people servants to him.

We should not be surprised that our financial system is a product of our sin and that Mr. X is YHWH's prison warden. YHWH has already made it clear through a number of utterances from his humble prophets that He alone determines the affairs of man (good and evil) and answers to no one:

"See now that I, even I, am He, and there is no elohim with Me: I kill, and I make alive; I wound, and I heal: neither is there any that can deliver out of My hand. For I lift up My hand to the shamayim (heaven), and say, I live le-olam-va-ed (forever)" (Devarim (Deuteronomy) 32:39-40).

*"With Him is strength and chochmah (wisdom): the deceived and the deceiver are His"* (lyov (Job) 12:16).

"See, I have created the blacksmith that blows the coals in the fire, and that brings forth an instrument for his work; and I have also created the mayim (the spoiler) that destroy" (Yeshayahu (Isaiah) 54:16).

"And He changes the times and the seasons: He removes melechim (kings), and sets up melechim (kings): He gives chochmah (wisdom) to the wise, and da'at (knowledge) to them that have binah (understanding)" (Daniyel (Daniel) 2:21).

"Consider the work of Elohim: for who can make straight, what He has made crooked? In the day of prosperity be full of simcha (joy), but in the day of adversity consider: Elohim also has appointed one as well as the other, to the end that man should find nothing after him" (Koheleth (Ecclesiastes) 7:13-14).

# Mr. X has a strong witness

Prophecy is undoubtedly on the side of Mr. X. What we are facing today in the world was foretold long ago. In the Essene Hummane Gospel of Christ (HGC) and the Gospel of the Holy Twelve (GHT), Yeshua listed a number of signs that will characterize the generation of the end:

"For in those days, the many shall be held in bondage but yet not in prison, and they shall be used to increase the riches of the greedy" (HGC).

"Those that have power shall gather to themselves in greed, the lands and the riches of the earth, for their own lusts, and thus shall oppress the greater number who have not" (HGC).

"And in those days those that have power shall gather to themselves the lands and riches of the earth for their own lusts, and shall oppress the many who lack and hold them in bondage, and use them to increase their riches..." (GHT).

"For in those days, the many shall be held in bondage but yet not in prison, and they shall be used to increase the riches of the greedy" (HGC).

What do all these prophecies share in common? You guessed it - DEBT! Right now, the world is run and controlled by debt, and the man who owns the system currently controls fifty percent of the world. When the melting point arrives, much more of the world's resources and rogue regimes will come under the dominion of the system, until one day, very soon, we wake up to find out that you do not own your country or your government. There is nothing the United Nations, any Super Power or army, or citizen can do about what has happened because it is all legal and all sanctioned by the nations through many agreements and treaties. A friend of mine asked me after reading this pre-release of this message, what should I do to prepare myself and my family? My advice is; do nothing, just enjoy your life.

#### Is there a way out?

There is only one way out of this, and it is not revolution or demonstrations. What I am now about to explain is primarily for Mr. X's consideration, but you are welcome to follow along as you are just as involved in this situation as I am. There is only one thing that Mr. X fears: YHWH and the voice that speaks on His behalf. In 2009 a major world event occurred to which the media and humanity were completely oblivious. In an article by this Ministry, we informed our readers of the significance of this event. Sadly I fear that very few actually understood the event described in the article. I now fear for humanity that the window is about to close, wherefore I expect some world-shaking events to follow to pre-empt us from reaching the equivalence point where TWI = TWV<sub>R</sub>, which will mean the destruction of the system. Such an event would be apocalyptic in nature; it will be beyond the control of Mr. X and the Brain and will, unfortunately, kill millions, possibly billions of people. The above-mentioned misunderstood article of this Ministry, with some of my updates, is reiterated below:

"We are compelled to write this proclamation (Mikra) to inform you of two Scriptural events of seismic implications for Christians and the gentile world. The events have received very little publicity or internet coverage because they have been hidden from the public eye at large in view of their far-reaching implications and the extraordinary possibilities involved when you come to understand your place in them.

# The first event is the end of the 2730 year punishment of the Ten Northern Tribes of Israel, which comprised the Northern Kingdom.

During the period of 745-721 B.C., the 10 Northern tribes were exiled by King Tilgat Pilsger 111 to Assyria and then to lands beyond the Euphrates, where they were eventually driven to the four corners of the Earth as Moses had prophesied in Devarim (Deuteronomy) 4:27 and 28:64.

The prophecy of Yechezkel (Ezekiel) 4:4-5 shows that they were to be punished for 390 years for worshiping Baal/Asherap. Having not repented after 390 years in captivity, the Northern tribes then had to endure the sevenfold increase of the penalty according to Wayiqra

(Leviticus) 26:27, 28 (70 X 390 years from 721 BC). That means they would be in exile for another 2,730 years. Using the perpetual Hebrew Calendar, this period formally ended in 2008.

# Why was this event vitally important?

We can make three main observations:

- The ten exiled tribes of Israel are still in exile
   1<sup>st</sup> Century historian Josephus said that the ten tribes of Israel were still in Diaspora
   beyond the Euphrates during his time and the Encyclopedia Judaic quoting ancient
   rabbinical sources agrees that the exiled tribes have not returned.
- 2. The ten exiled tribes are the Church and the Gentiles According to the prophecy of Genesis 48:19 the two sons of Joseph were to become meloha' goyim literally "the fullness of the Gentiles," and the firstborn blessing was bestowed by Jacob upon Ephraim who had a gentile mother, which meant that Ephraim would become the dominant tribe.
- 3. The ten exiled tribes are to be grafted back into the olive tree of Israel Collectively the ten tribes came to be identified under the banner of Ephraim that is pictured in Paul's olive tree analogy of *Romans 11* as the wild branch that was broken off because of unbelief and would be grafted back in.

## What are the implications of this?

It means that Ephraim's period of prolonged captivity is over! YHWH will once again extend His mercy, love, and compassion to Ephraim, and recover and re-join the ten tribes to Israel (Yeshayahu (Isaiah) 11:11-14, 27:9; Yirmeyahu (Jeremiah) 3:14-18, 16:11-16, 50:4-5, 20; Yechezkel (Ezekiel) 37:22-26; Zecharyah (Zechariah) 8:3, 7; 13:7-10; Hoshea (Hosea) 1:11; Ovadyah (Obadiah) 1:18; Schmuel Alef (First Samuel) 17:45).

Therefore expect to see a longing and desire among Christians and Gentiles alike:

- To learn Hebraic thinking and understanding;
- To learn the customs and traditions of the Hebrew people; and
- To learn Hebrew dancing and music.

Thus, we will begin to see Christians and gentiles everywhere returning to their Hebrew roots. There will also be an increase in Hebraic publications and activities in your area.

# The second event is the end of the 3,430 year period from when Israel celebrated its first Jubilee.

Israel was instructed by Moses to begin counting Sabbath years and the Jubilee cycle when they entered the promised land (Leviticus 25). They were to start counting immediately after they crossed the Jordan. We know from *Joshua 4:10* that Israel kept the Passover on the 14<sup>th</sup> of Aviv after they crossed the Jordon. Using the perpetual Hebrew Calendar Bible, scholars have determined that Joshua kept the Passover in the year 1422 B.C.

Since we do not count the year 0 A.D., the preceding year AD 1 was the year 1 B.C. To simplify calculations, astronomers refer to 1422 BC as -1421. So 2009-(-1421) = 3430 years = 70 X 49 years. This means that the 70<sup>th</sup> Jubilee of Israel began on the 1<sup>st</sup> of Aviv or March the 27<sup>th</sup> 2009 as Moses was instructed that the 1st of Aviv was to be the start of the Biblical year

(Shemoth (Exodus) 12:2). According to the Torah (Wayiqra (Leviticus) 25), the Jubilee started on the day of Yom Kippur with the blowing of the Shofar.

# Why is this event vitally important?

Again, we can make three main observations:

- 1. The Church is in financial captivity At the end of every 49<sup>th</sup> year, debts were to be released, land, houses, and possessions were returned to their former owners. Every man was given a new start and position.
- The Church has the identity of Rome and Greece Israel was given a new identity as they entered the Promised Land. The Book of Yahoshua (Joshua) tells us, *"This day I have rolled away the reproach of Egypt from you"* (Yahoshua (Joshua) 5:9). They were to become a kingdom of Priests - a set-apart people.
- 3. The Church is still living off manna This was also the day when the Manna ceased, and Israel was to live of the words of the covenant by which they had pledged themselves to keep. When they did, they reaped the blessings of the covenant.

# What are the implications of this?

It means we have entered into a period of unparalleled restoration! YHWH will once again restore to His people His name, His covenant, their heritage and a pure speech (Devarim (Deuteronomy) 33:4; Yeshayahu (Isaiah) 1:26, 29:23, 49:6, 52:5-6; (Yirmeyahu (Jeremiah) 16:19-21, 31:31-34; Tehillim (Psalm) 37:9-11, 27-34; Tzephanyah (Zephaniah) 3:8-13; Yoel (Joel) 2:23-27, 32).

Therefore expect to see a longing and desire among Jews, Christians, and Gentiles alike:

- To learn the language and script of the Bible, Hebrew,
- To learn the structure and function of the original assembly, and
- To learn the role and function of the priesthood of Melchizedek.

Thus, we will begin to see Jews, Christians, and gentiles everywhere returning to the Torah and the Prophets. There will also be liberation from debt and provisions released to begin new works and ministries in your area.

A warning! As rabbis, pastors and leaders, we need to recognize where the wind is now blowing and begin to adjust our sails now, or you may just find your ministry heading against the wind and being blown right off course."

# So what happened?

Well, we know what happened in 2008: Instead of prosperity, restoration, and liberty, the world plunged into a financial downturn which would have seen a repeat of the 1930's world depression had not Governments stepped in and rescued the economy and the nations. I have read many intriguing and interesting reports on the crisis, which can be challenging if you do not have a financial or economic background. Many theories have also been postulated and predictions made from among many intellectuals and disciplines. Our friends at Wikipedia have provided this neat little summary of the reasons for the crisis, which basically covers the lot:

"The crisis resulted from a combination of complex factors, including easy credit conditions during the 2002–2008 period that encouraged high-risk lending and borrowing practices without assessing default-risk; international trade imbalances; real-estate bubbles that have since burst; fiscal policy choices related to government revenues and expenses; and approaches used by nations to bail out troubled banking industries and private bondholders, assuming private debt burdens or socializing losses."

The US Government, of course, published its own report amidst many allegations that they actually caused the crisis. The majority report of the U.S. Financial Crisis Inquiry Commission (supported by 6 Democrat appointees without Republican participation) reported its findings in January 2011, concluding that:

"The crisis was avoidable and was caused by: Widespread failures in financial regulation, including the Federal Reserve's failure to stem the tide of toxic mortgages; Dramatic breakdowns in corporate governance including too many financial firms acting recklessly and taking on too much risk; An explosive mix of excessive borrowing and risk by households and Wall Street that put the financial system on a collision course with crisis; Key policy makers ill prepared for the crisis, lacking a full understanding of the financial system they oversaw; and systemic breaches in accountability and ethics at all levels."

The experts may have identified the causes of the crisis, but they have certainly not uncovered its root cause. All of this economic jargon is a smokescreen that has blinded YHWH's people from the root cause of the problem. The root of this problem lies in what Mr. X could not bring himself to do in 2008-9 that YHWH had programmed the system to perform. It is capsulated in one simple word *Yovel* or Jubilee - it is epitomized in the immortal command of Moses to Pharaoh, "let my people go!" Before going onto YHWH's solution to the problem, allow me to explain what a Yovel is and why it is such a major event in the Torah and indeed in our economic and financial system. Long before we had money and world trade, YHWH gave the parameters for the systems.

#### What is Yovel?

The English word "iubilee" comes from the Hebrew word Yovel meaning a trumpet or ram's horn. Rams' horns were blown on the Day of Yom Kippur (Atonement) to announce the start of the Year of Jubilee. The idea of a Jubilee, though, is based on the universal law of the Shabbat or the number seven. The Torah establishes a chronological system based on the division of history into periods of years, weeks and jubilees. According to this scheme, (a), seven days constitute a week, (b) seven weeks constitute a pentecontad cycle, (c) seven pentecontad cycles constitute a year, (d) seven years constitute a sabbatical cycle, (e) and seven sabbatical cycles (shmita) constitute a Jubilee. The Book of Jubilees that was found among the Dead Sea Scrolls shows that time was organized according to this scheme which leads me to believe that the written and unwritten history of mankind is arranged on the basis of this calendar. The division of time and history into seven is central to the author of the Torah in understanding YHWH's plan for the ages. According to the Torah, the people of Yisra'el as YHWH's covenant community were specially entrusted with keeping the Sabbath, the Feasts, and Jubilee. They were therefore commissioned to teach their freedoms and liberties to the nations. Unlike the year and the month, the week has no basis in nature but was mandated by our Creator as a part of the creation week and man's creation. The division of time is found in several places in the TaNaK (The Hebrew Scriptures). The Feast of Weeks, the Day of Jubilee, and the length of Passover are based on the number seven. Aspects of the service of the Temple incorporated the number seven, such as the number for sacrifice, the length of time until purification and the number of lamps on the menorah. Seven is also a part of the

narrative sections of Torah, such as the length of Jacob's service in Haran, the length of the drought in Egypt, and the number of times Yisra'el was to march around Jericho.

Even in the natural world, the number seven is highly prevalent. For example, according to Jewish Kabalah, there are seven heavens or celestial levels. The Kabalah also teaches that there are seven parts to the human body: the head, the torso, two arms, two legs, and our *britmilah* (sexual organ). We have seven inlets in our head; two eyes, two ears, two nostrils, and one mouth. When we divide our body into two vertical sections, we have three inlets on each side, one ear, one eye, one nostril, and the mouth in the center, being the seventh. This is a picture of the menorah. Then there are seven continents in our world: Africa, Antarctica, Asia, Australasia, Europe, North America, and South America. There are seven great seas: Arctic Ocean, Antarctic Ocean, Indian Ocean, North Atlantic Ocean, South Atlantic Ocean, North Pacific Ocean, and the South Pacific Ocean. There are seven major plates in the Lithosphere (the outer crust of the Earth's surface) and several smaller ones. There are seven colors in a rainbow: Red, Orange, Yellow, Green, Blue, Indigo, and Violet. There are Seven States of matter in the universe: Solid, Liquid, Gas, Plasma, Beam, Bose-Einstein Condensate (zero matter), and Thought Wave.

# What is the significance of this?

The great Hebrew scholar Julian Morgenstern was one of the foremost experts on the calendars of Ancient Yisra'el. He concludes there is strong evidence that a calendar, called the Pentecontador Jubilee calendar, was used in Palestine during the time of Moses and, more likely, even earlier, at the time of Abraham. While many of the details of this calendar have long been lost, Julian describes a similar calendar that has been used by modern Christian Palestinian peasants. The evidence may be sparse, but it is clearly there that humanity has always observed the Jubilee calendar as part of its observance of the Sabbath. Moses did not create another chronological system; he took that which was practiced by mankind that Adam had established and the patriarchs had perfected and organized the system into a uniform code of law. Moses was well equipped to record the workings of this system; he received a royal education in the house of Pharaoh, where he was trained as a lawyer, a philosopher, mathematician, astrologist, and administrator. He was groomed to be judge and ruler of Egypt, but YHWH arrested his promising career.

In the code, Moses set the parameters in the system so that at the beginning of every fortyninth year, it would bottom out (reach its lowest point), and certain events were programmed to occur for the wellbeing and prosperity of mankind so that by the fiftieth year, two years later the system would be again at its zenith (maximum point). Even the celestial bodies were preordained to show the signs of the time, and Heaven itself would lead the festal array. Among the realm of men, Jubilee would be a time of great rejoicing and celebration that was to last for two years, beginning on the 49th year. Moses understood the importance of having a written code to regulate the life of mankind, and he organized the system to reset at Yovel so that evil would not triumph and again provoke the hand of the Creator. Of particular importance here is the part of the code covered in Wayiqra (Leviticus) 25:1-18:

"1 And YHWH spoke unto Moshe in mount Sinai, saying: 2 Speak unto the children of Yisrael, and say unto them, When you come into the land which I give you, then shall the land keep a Sabbath unto YHWH. 3 Six years you shall sow your field, and six years you shall prune your vineyard, and gather in the produce thereof. 4 But in the seventh year, shall be a Sabbath of solemn rest for the land--a Sabbath unto YHWH--you shall neither sow your field, nor prune your vineyard. 5 That which grows of itself of your harvest, you shall not reap, and the grapes of your undressed vine, you shall not gather: it shall be a year of solemn rest for the land. 6

And the Sabbath produce of the land, shall be for food for you: for you, and for your servant, and for your maid, and for your hired servant, and for the settler by your side that sojourns with you, 7 And for your cattle, and for the beasts that are in your land, shall all the increase thereof be for food. 8 And you shall number seven Sabbaths of years unto you, seven times seven years: and there shall be unto you, the days of seven Sabbaths of years, even forty and nine years. 9 Then shall you make proclamation with the blast of the shofar, on the tenth day of the seventh month. In the Yom Kippur, shall you make proclamation with the shofar throughout all your land.10 And you shall Set-Apart the fiftieth year, and proclaim liberty throughout the land unto all the inhabitants thereof: it shall be a yovel unto you, and you shall return every man unto his possession, and you shall return every man unto his family. 11 A yovel, shall that fiftieth year be unto you. You shall not sow, neither reap that which grows of itself in it, nor gather the grapes in it of the undressed vines, 12 For it is a yovel. It shall be Set-Apart unto you; you shall eat the increase thereof out of the field. 13 In this year of yovel, you shall return every man unto his possession. 14 And if you sell aught unto your neighbor, or buy of your neighbor's hand, you shall not wrong one another. 15 According to the number of years after the yovel, you shall buy of your neighbor, and according unto the number of years of the crops, he shall sell unto you. 16 According to the multitude of the years, you shall increase the price thereof, and according to the fewness of the years, you shall diminish the price of it, for the number of crops does he sell unto you. 17 And you shall not wrong one another, but you shall fear your Elohim, for I am YHWH your Elohim. 18 Wherefore you shall do My statutes, and keep My ordinances and do them, and you shall dwell in the land in safety."

According to the regulations, the Jubilee began on the day of Yom Kippur with the blast of the ram's horn (shofar) and was to be sounded once 49 years had been counted. This raises an ambiguity causing scholars and classical rabbinical sources to be divided on the question over whether the Jubilee was within the 49th year or followed it as an intercalation in the seven-year sabbatical cycles. For me, the Torah mandates that the 49<sup>th</sup> year is the start of the Jubilee, and the process culminates in the 50<sup>th</sup> year. The scriptural requirement is that the Jubilee year was to be treated like a Sabbatical year, with the land lying fallow, but also required the compulsory return of all properties to their original owners or their heirs, in addition to the manumission of all indentured servants. Torah regulations state that the land was to rest a Sabbath when the Children of Yisra'el came to Canaan, the land YHWH gave them as an everlasting possession.

#### In summary, the Torah requirements for the Yovel year are:

1) We perform no agricultural work on the land in the last year of every seven years that we consider all produce which grows (by themselves) that year as ownerless and allows the poor and the animals to have them;

2) We cancel all loans between persons and clear our ledges in this seventh year;

3) We treat the last year of every fifty years just like we treat the seventh year, abstaining from agricultural work, etc.;

4) We free all slaves in this fiftieth year; and

5) We return to the original owners all land that has been sold in the past forty-nine years.

It must be noted that Yisra'el had been in captivity for 430 years in Egypt and had lost their freedom, therefore, their right to exercise the law of the Jubilee. A punishment that no doubt had stemmed from them not honoring the Jubilee and not obeying the Torah - a repeat of what we now have today with billions of people in captivity. As a natural consequence of their sin, YHWH allowed them to become indentured servants and slaves. YHWH summoned Moses

to deliver Yisra'el on the eve of the fiftieth jubilee from the time of Adam; to be exact - 2,500 years from Adam. This was the same year that the Israelites came out of Egypt! It was literally a jubilee of jubilees, or we could say a sabbath of sabbaths or sabbaths of sabbaths! This event was no ordinary Shabbat but should be considered as the all-time standard. The Exodus then was a precursor or foretaste of what a Jubilee would be like - the ultimate example whereby we can measure subsequent jubilees.

The Exodus was the greatest release of slaves the world has ever seen. It was also the start of the process by which the land of Canaan returned to its rightful owners. YHWH had promised the land of Canaan to Abraham and his descendants (the line of Shem) but was stolen by Canaan. When they were set free from Egypt, the way was open for them to march in and reclaim their inheritance. Fifty days after the Exodus on the day of Shavuot (Pentecost), the Israelites arrived at Mt. Sinai. We read in Shemoth (Exodus) 19: 16 'On the morning of the third day there was thunder and lightning, with a thick cloud over the mountain, and a very loud trumpet blast. Everyone in the camp trembled.' This was nothing other than the Shofar of Jubilee.

Thereafter Moses commanded Joshua to celebrate the Jubilee when they entered the Promised Land (Wayiqra (Leviticus) 25). The origination of the counting didn't actually start at the time the Hebrews entered into Canaan, which was forty years after the exodus (Yahoshua (Joshua) 5:6), but rather after they finished conquering the land and after apportioning it to each family, which was some ten years later according to 12<sup>th</sup> Century Jewish scholar and philosopher Maimonides (Laws of Shmita) and the book of Jubilee 10:2. The dates range from 1432 or 1288 BCE depending on which calendar you use - the Rabbinic Calendar or the Jubilee Calendar. It must be noted that Yisra'el has observed many calendars, some Torahbased and some pagan in her history, and continue to do so today, perpetuating her confusion.

The law of Jubilee and particularly the Jubilee calendar was observed in Yisra'el up to the period of the First Temple. By the time of the Second Temple, it was abandoned but still counted. Its observance was transferred to an exile community of priests known as the Essenes that had broken away from the Temple order some 500 years before the destruction of the Second Temple. Non-kohen priests and non-Torah practices had been allowed in the Temple, which led to the split. The Essenes kept the Jubilee Calendar intact and maintained its code as it was taught in the Torah of Moshe. The ruling body of the Temple, the Sanhedrin, created their own calendar based on the moon sightings and relegated the Jubilee to a symbolic grave. After the destruction of the Second Temple and the disbanding of the Sanhedrin, the counting of the Jubilee was suspended, and this has been the case ever since.

The Essenes continued the practice of Jubilee, understanding its divinity and authority was not based on the existence of the Temple or the Sanhedrin since the law remained applicable as long there is a vestige of Yisra'el willing to teach the Torah to humanity. In the diaspora, the descendants of Abraham continued to observe its code in symbolic ways. Still, they were also aware that when the Jubilee arrived, which they counted, YHWH would either send a deliverer or do an extraordinary thing to mark the year, as the following table shows.

When the carriers of the light, the Essene movement, were finally dispersed sometime in the 3<sup>rd</sup> Century C.E, its priesthood, holiness code, and beliefs were absorbed by auxiliary movements it flowered in its day. The Way, the Nazarene, the Ebonites, Chasidism, etc., and to some extent, Christianity all carried the Essenic touch. These movements continued the traditional count of the Jubilee as a symbolic gesture but not in the spirit and manner that YHWH had commanded Moses to observe it and teach mankind. In fact, since the time of Moses and Joshua, mankind has not experienced a real Jubilee. Therefore I foresee a Jubilee that will be greater than the Jubilee of Moses' day; a day in which the whole earth will rejoice and celebrate with unity and love.

#### What did Moses want us to understand?

Very few people understand the "big picture" that Moses wanted us to see. As loyal and patriotic he was to his people and nation, Moses knew the heart of the Eternal Father was towards all of mankind and not just tiny Yisra'el. Therefore, Moses understood that no instruction of the Torah is specific to Yisra'el, whose existence as a set-apart people is based on their mission to teach the nations its tenants and precepts. The Torah existed before the creation of the Universe. According to *Zohar Terumah* 161b (a revered mystic work), YHWH looked at the Torah and created the world. Thus, the essence and validity of the Torah is man. At the micro-level, the book of Wayiqra (Leviticus) states that the Jubilee existed because the land of Canaan is the possession of YHWH, and its current occupiers were merely aliens or tenants. Therefore the land should not be sold forever. At the macro-level, the code of Moses taught that the earth and its resources belong to YHWH. Therefore, Earth should not be sold forever. Indeed we have many witnesses, some of which are quoted below:

*"The earth is YHWH's, and the fullness thereof: the world, and they that dwell therein"* Tehillim (Psalm) 24:1;

*"For every beast of the forest is Mine, and the cattle upon a thousand hills"* Tehillim (Psalm) 50:10;

"Mine is the silver, and Mine the gold, says YHWH Tzva'ot" Chaggai (Haggai) 2:8; and

"Who has given Me anything beforehand, that I should repay him? Whatsoever is under the whole heaven is Mine" Yob (Job) 41:11.

The above witnesses demonstrate that Yovel is a law for mankind. The continued observance or violation of this law will either bring a blessing or a curse upon the earth. Further, it was not a coincidence that Moses connected the Jubilee to the day of Yom Kippur. Symbolically we understand this moment as a day when YHWH sets us free from our sin and bondage provided one performs teshuvah (Torah repentance) during the traditional ten days of awe (see our book *Moedim exposition of the feasts*). On the other hand, failing to perform the obligations of Yom Kippur generally resulted in the opposite - a judgment or a curse. However, when this day is connected to Jubilees, it takes on monumental proportions and has far-reaching effects. When the Jubilee arrived on the Day of Atonement, and its provisions are carried out to the letter, the blessing is amplified seven times, but when the day is not observed, and its freedom trashed, it results in a sevenfold penalty according to Wayiqra (Leviticus) 26:27-28 which would last for centuries. In 2008 it was the 49<sup>th</sup> year - the start of your Jubilee, and in 2009 the clock struck 50<sup>th</sup> at sunset on the day of Yom Kippur.

#### But what happened instead?

On September 29<sup>th,</sup> 2008 - the start of the traditional ten days of awe the Dow Jones, the biggest financial market in the world, hit its all-time low and continued to spiral for weeks. By the day of Yom Kippur on October the 8<sup>th</sup> in that year, the losses were in the trillions. Some estimates place the debt created by the crisis at 10 trillion US dollars in the US alone. We have no idea of the real losses that it caused in other markets and countries. The spread and scope of the crisis were only narrowly averted through massive borrowings in which the US government took from the system on the back of its citizens. Effectively all your leaders did was transfer the debt from the private sector and heaped it on their existing government debt in the system. The debt is now impossible to pay back, and anyone who tells you it can is lying. However, you should not be concerned at this stage unless what I am going to propose in this message fails to come about.

The situation in which America and the world have descended is ironically no different from how Moses found Israel in Egypt; they had become indentured servants and slaves. They were no longer human beings but commodities. Comparatively speaking, every man, woman, and child is now a slave in a prison of debt, and our modern taskmasters are not going to let anyone go free in case they compromise the system. It does not matter how much money or influence you have; it is all tied to the world debt in the system, and like a massive fishnet in the ocean, it will drag everyone in and underwater. And with the way the law of the land has been written by legislators and appended by the courts, the money lenders have been given all power and all authority to collect when the time comes, and there is no mercy and forgiveness built into the law. And make no mistake, they will use their authority and position.

At this point, you should know your inalienable rights and non-rights that your Creator provided in the Torah; here they are:

You have a right to:

- 1. A decent piece of land and shelter you can call home;
- 2. Wholesome and affordable supply of food, clothing, and life's amenities;
- 3. Peaceful and lawful co-existence with your neighbor(s);
- 4. Clean air and clean water;
- 5. Education and training for your vocation;
- 6. A job that can provide for your existence;
- 7. Freedom of religion, speech, and movement;
- 8. Fair representation and good governance;
- 9. A stable and equitable economic and financial system;
- 10. A meditative and reformative legal system;
- 11. Medical treatment and health care system;
- 12. Keep and bear arms;
- 13. Recreation and set apart days; and

14. A day of rest, a sabbatical, and a jubilee.

You do not have the right to:

- 1. Kill another human being unless it preserves your life or another
- 2. Kill the unborn;
- 3. Kill animals, birdlife, and sea life unregulated;
- 4. Kill ideas and belief systems that are contrary to your own;
- 5. To destroy the environment;
- 6. To take what belongs or is bestowed to another;
- 7. To destroy freedoms and liberties;

- 8. To live destructively and unregulated;
- 9. To own another human being;
- 10. Not work;
- 11. Not go to school;
- 12. Not to contribute to your country's sovereignty;
- 13. Not to contribute to your country's economy; and
- 14. Not to contribute to world prayer.

#### Is there hope for us all?

Yes, there is hope in Mr. X, the servant of YHWH! Thus, I am appealing to Mr. X on behalf of the world's seven billion people to do something about the situation before YHWH steps in and destroys the system along with billions of human beings. And as I have shown, there is no need to trust me on this one. YHWH will do it when all common sense and reason fail. You should be aware there is a Plan B. However, I fear we may have come past the Maginot Line with Plan A, now Plan B is active.

#### What can Mr. X do in Plan A?

What he alone can do is to RESET THE SYSTEM! To do this, he must do four things:

- 1. Conditionally cancel all public debt in the system and eliminate all government debt;
- 2. Conditionally cancel hard currency and eliminate all private debt;
- 3. Conditionally appoint a World Banker; and
- 4. Conditionally appoint a World Caretaker.

It is understandable that in response to the above Mr. X will require all governments under strict guidelines to:

Note this is not an exhaustive list but only a guideline.

- Free all indentured prisoners;
- Free all political and religious prisoners;
- Free all restraints on private enterprise;
- Nationalize all resources for national services and industrial use;
- Nationalize all lands;
- Nationalize all intellectual property;
- Nationalize all businesses that provide primary resources;
- Nationalize all businesses that provide national services;
- Nationalize all lending;
- Nationalize all leasing; and
- Nationalize government and industry positions so that officials are not elected but selected for their job.

Under strict control limits, national holdings should then:

- Provide land for private, business, public, and government use;
- Provide credit allocations for old and new businesses;
- Provide free enterprise;
- Provide consumer lending;
- Provide free education;
- Provide free medical services;
- Provide free family support;
- Provide free food support in schools and workplaces;

- Provide free internet and television;
- Provide free public transport;
- Provide free electricity and water; and
- Provide other free services as required.

Under strict supervision, legislators should then:

- Repeal tax laws;
- Repeal property laws, real and intellectual;
- Repeal zoning laws that restrict movement and travel;
- Repeal private industry laws;
- Repeal business and finance laws;
- Repeal any other laws and regulations that promoted the old regime;
- Establish new anti-pollution laws;
- Establish new anti-corruption laws;
- Establish new anti-monopoly laws;
- Establish new anti-slavery laws;
- Establish new anti-discriminatory laws; and
- Establish any other laws and regulations that promote the new regime.

## Can we stop this situation from repeating itself?

To avoid the destruction of man from ever occurring again, we must rethink our position and support the following initiatives:

- Creation of a world currency and allow for regional currencies to eliminate speculation with money and commodities;
- Creation of regional sovereignties (Councils) to manage regions of the world;
- Creation of an Earth Bank to manage the national Central Banks that will create monetary holdings for every country based on the size and output of their economy so that the system will run on credit;
- Creation of an Earth Court to hear all threats to world peace, harmony, and health with regional courts;
- Creation of an Earth Council for religious freedom, expression and movement under the United Nations with regional centers;
- Creation of a Ruling Council to head the United Nations;
- Centralization of all international threat monitoring under the United Nations while countries can retain their secret services;
- Creation of an Earth Council for the protection of biodiversity under the United Nations
   with regional bodies;
- Centralization of all military commands under the United Nations while countries and regions can retain their standing armies;
- Centralization of the IMF, the World Bank, and any other similar institution under the United Nations to provide for the development of all countries and respond to world catastrophes and disasters;
- Centralization of all, space travel, and exploration under the United Nations;
- Centralization of control of all seas and poles under the United Nations; and
- Centralization of the management of all no man's zones (including lands undersea, all airways, and satellite regions) under the United Nations.

Some may see all of the above as formulation for global government and fear the concentration of such power under one great assembly as the United Nations but make no mistake; this will prepare the foundation for a Kingdom Government, not a secular

Government. All that has to be accomplished when the time arrives is for the King of kings to take His place as the head of the system and the UN. Unfortunately, through many wild and weird teachings, many religions and denominations are guilty of propagating fables and fantasies about the world to come (Olam Haba) and the coming of the Messiah, to such an extent that we no longer approach this topic with reason and common sense. In this regard, we should be reminded of what Mahatma Gandhi, one of the greatest leaders of the 19<sup>th</sup> Century, said: *"The truth by nature is self-evident. As soon as you remove the cobwebs of ignorance that surround it, it shines clear."* 

The Moshiach will not come until we clean up the mess we have created, and we should not think it proper that YHWH does it for us because it is well within our ability and power and indeed our responsibility. Mr. X can trigger the beginning of Yowel, but it will be up to all of us to see it through to our family and children, our neighbors and community, our towns and cities, and our country and the world. Everyone has a vital role to play in Yovel, and no one is exempted. When we have successfully returned to YHWH's calendar, the Kingdom of Heaven will come to Earth. When that happens, none of our families, children, and neighbors will ever be hungry again, or homeless, or in fear or want of their life because LOVE will become the supreme law of the earth. The New World (Olam Haba) will not be built on a mountain of debt but on surpluses that nations will contribute to and draw from for global development and prosperity.

In the sad case, that mankind refuses to change as it was in the Days of Noah. Then global Judgement will come, in which case we must also prepare, and Plan B is outlined in our book *Yom YHWH*. I leave you with this short prayer which I humbly ask that you pray until Yovel happens.

"Our Abba who art in the shamayim; exalted be thy name Yahuweh. Thy kingdom come on Earth, Amen."

Barukh haba b'shaym יהוה, Halleluyah! Praised is He who comes in the name of יהוה!
